The COLTIVA CORTI DIRETTI contest is composed by four sections:

A – Rural Short Film Section

B – Rural Documentary Film Section

C – Free Theme Short Film Section

D – School Short Film Section

The Festival is finalized for promoting the rural territorial identity in expressive and artistic form through the audiovisual.

The contest is open to short films, documentaries, animation, video clips, experimental videos, video surveys, produced in Italy and abroad. To access the selection, foreign works must have subtitles in Italian. The works must not exceed the maximum duration of 15 minutes including the opening and closing title

HOW ATTENDING

- 1) The works can be sent:
 - in high resolution digital format preferably by WeTransfer, DropBox, Google Drive, etc. at the e-mail: festival.coltivacortidiretti@gmail.com
 - by post or express courier in DVD to the address: COLTIVACORTIDIRETTI p/so Compagnia GENITORI INSTABILI Via Case Sparse 10 Valle di Casalmaggiore (Cremona)

For every single work it is obligatory to provide the following documents:

- the Announcement, Registration form, Release (for each single work) of age and / or minors, completed in all its parts **in block letters and signed** .
- High quality representative photos of the work in jpeg, at A4 and A3 format (at least 300 dpi), poster of the film (where available).

-The deadline for sending the material remains fixed for **2022, 20 May**

-Sending all the required material is borne by the participants.

The organization is not responsible for damage or loss of material sent by Post or Courier

- 2) No registration fee to the Festival COLTIVACORTIDIRETTI 2022.
- 3) Each work must include the Festival Announcement, the Registration form, the Release for adults and / or minors for the COLTIVA CORETTI DIRETTI 2022 filled in all its parts and signed. The sending of the Announcement and the registration form implies the integral acceptance of the present regulation.
- 4) By accepting the regulation, the participant authorizes the organization to process his personal data for purposes related exclusively to the contest and in accordance with the provisions of Legislative Decree No. 196 of 30 June 2003.
- 5) The works sent will not be returned and will become part of the Festival's archive, they can be used in the context of their own cultural activity, not for profit and exclusively for educational purposes, free screenings, without the author of the work itself can move any economic claim for rights.
- 6) The author and / or the production declare that the short film and / or documentary does not infringe the rights of third parties, according to the law, 22/04/1941 n ° 633 and subsequent amendments (copyright), does not present content of a defamatory nature and clearly harmful to human and social rights.
- 7) The authors and / or productions of short movies and / or documentaries authorize the screening of all sent works
- 8) The COLTIVA CORTI DIRETTI Festival organization declines all responsibility due to the reproduction of short films and / or documentaries containing material covered by copyright, for which the position with SIAE has not been regularized. Each author is responsible for the content of the work presented.

COLTIVA CORTI DIRETTI WORKS PRESELECTION

All the works will be pre-selected by the Artistic Direction which, according to their unquestionable judgment, based on their artistic value and / or content, will select the works admitted to the various sections.

Participation in the competition can be refused to videos that technically can't guarantee a good public screening on large formats. Products that are not technically suitable may be excluded
